## **Application for Animal Breeder Approval**

Local Law No. 1 (Administration) 2011

Local Law No. 2 (Animal Management) 2011 and Animal Management (Cats and Dogs) Act 2008

## **IMPORTANT INFORMATION**

- Approval is required if a person intends to, allows, or encourages a breeding cat to breed with another entire cat.
- At the time of lodging an application, ALL mandatory documentation must be supplied.
- Animal owners who are registered breeders in another Council or from interstate (current approved breeder) need to meet the above requirements.

If the property exceeds the number of allowed animals, an "Application for Approval to keep an Additional Cat" is required. Application form to be lodged separately and fees apply.

If breeder moves address within the region and they have more than the allowed number of animals; a NEW additional animal permit must be lodged as additional animal permits are not transferrable to another property.
