Once Registered, as Licensee I agree to the following conditions:			
 The grid shall be numbered as per with the Registration Number allocated by Council being prominently displayed on the grid. The grid shall always comply with the conditions stated in current Local Laws for the Fraser Coast Regional Council. The grid, including gates, fences, signs and surrounds shall be maintained in good order to ensure its continuing safe use. Provide proof (attached to this Application) of a certificate of currency for public liability insurance of not less than \$20 Million or a greater amount if set by Council and maintain this insurance for one year from the date of approval. Agree to reimburse Council for all costs incurred should Council deem it necessary to carry out urgent maintenance to the grid and the road approach up to 5 metres from the grid for safety purposes. Indemnify the Council against any claim for damages. Remove and destroy all declared noxious weeds and plants growing in the road reserve within a 5-metre radius of the grid. Notify Council in writing that the grid is no longer required, enabling Council to cancel the Registration. In the event the Registration is cancelled, due to failure to maintain the grid in a safe condition or pay the annual License Fee, after 30 days from the date of cancellation Council will deem the grid unfit and programme the works required to remove the grid and reinstate the road as soon as resources are allocated.

1. A Registration Application Fee of \$717.00 will be applicable for a new grid within the public road reserve.			
2. An annual fee of \$210.00 will apply thereafter.
