



Urban Street Naming

New Urban Road Names

All applications for new road names should be submitted on the prescribed "Application Form – Urban Street Name" available from the Development section of Council's website. Please include a road layout plan and any future road extensions.

The form can be submitted to the Development and Planning Department (Hervey Bay or Maryborough counter) or by email to development@frasercoast.qld.gov.au.

Applicants are required to submit two names for each road, and their relevance.

Preferred sources of names include but are not limited to:

- Indigenous names
- Flora, fauna, geographical or cultural features
- Landscape and physical forms
- Australia
- Australian animals and birds
- Historic house names
- People who excelled in sports or in the arts
- People who served the community well
- Pioneers and long-term land holders
- Explorers and Surveyors

Particular attention should be taken in determining the correctness of the spelling of the proposed names.

Names that are not preferred are those that:

- Are difficult to pronounce or very long/composed of two words
- Are difficult to spell
- Are hyphenated words
- Are plural or possessive (ie: Stewart's or Stewarts Street)
- May offend or seem to be offensive
- Already in use on the Fraser Coast

Council may:

- Select any name submitted by the applicant or select such names it deems appropriate
- May change the name
- May not select any name that is the same name of another road in the regional area (within the same post code locality)

Final Steps:

Once approved, road names are to be shown on engineering drawings when these are submitted with a Reconfiguring a Lot Application; and road names are to be shown on the plan of survey that is submitted when requesting a Plan of Subdivision.
