

Notice of Intent to Install or Refurbish a Monument or Plaque in Cemeteries Administered by the Fraser Coast Regional Council.



New installations An Application for Installation of Monument/Plaque and current application fee is required. The application must include the dimensions of the plaque or monument. In the case of a monument the footings should also be included.

Once Council has approved the application, a copy of the approval will be sent to the stone mason/contractor. No work is to commence until the application has been approved.

A Notice of Intent form must be submitted at least 48 hours prior to commencement of any work within a cemetery.

Refurbishments of existing plaques A Notice of Intent form must be submitted at least 48 hours prior to commencement of any work within a cemetery.

If the style or dimensions of the original plaque/monument are to be altered the Notice of Intent must include the dimensions of the plaque or monument. In the case of a monument the footings should also be included.

The office is located in the Maryborough Garden of Rest Lawn Cemetery, Walker Street, Maryborough.

Strictly no weekend monumental work is to be undertaken unless prior approval has been granted.

All rubbish to be taken off-site when monument is completed. Surrounding area to be left clear of any concrete and gravel waste.

All plaque and monuments must comply with Australian Standard AS4204-1994, AS4425-1996

Installation requirements for individual sections of the Cemeteries are as follows:-

Each plot is 1.2 metres wide and 2.4 metres long with the head of the grave being on the western extremity or closest to the concrete beam (if applicable). The plot is marked by 4 pegs at each corner and these are driven in just below ground level. It is imperative that these pegs be uncovered before commencement of any work.

The stonemason/contractor should note that due to the age of the cemeteries, slight inaccuracies might be found in the spacing and alignment of gravesites. It is the duty of the stonemason/contractor to work within these anomalies, ie the size of the plot can vary slightly and the alignment of the graves might be slightly out. The stonemason/contractor must work within the defined area and square up the site they are working on to match up with existing graves. Surrounding graves are not to be interfered with.

Graves are dug so that there is at least 37.5 centimetres of untouched earth at the head of the plot. It is in this position that the concrete block and plaque/headstone is to be laid. Plaques in lawn sections must be laid level with the ground, or in the case of beamed sections, within the beam and in accordance with Council's requirements for height.

Council's official grave number must be embedded in the lower right hand corner of the concrete block/monumental border.

A safety site induction will be required. Regular stone masons/contractors will only require a site induction before their first installation; any new staff will also require a safety induction.
