Time frames for response may vary.

TRANSFER CONDITIONS

The transfer/sale enables to customers to transfer water.

The seller's remaining allocation of water will be reduced by the Nominated Transfer Volume. The water available to the buyer will be increased by this volume.

The transfer/sale does not alter the buyer's or seller's conditions for the taking of water from a channel, pipeline or river.

Application Process

To apply for a transfer/sale, the buyer and seller should complete and sign this application form and submit it to Fraser Coast Regional Council.

Upon receiving this application form and payment of fee, Fraser Coast Regional Council will provide buyer or buyers representative with a copy of the Supply Contract to which will need to be understood and signed by the buyer as part of their application.

Fraser Coast Regional Council will also supply the Department of Natural Resources, Mines and Energy *Notice to registrar of water allocations of existence of supply contract Form W2F152* signed by a Fraser Coast Regional Council Representative.

This application form does not deem a water allocation transfer complete. An application must be made to the Department of Natural Resources, Mines and Energy to transfer allocation ownership.

Finalisation of Transfer

Fraser Coast Regional Council will not deem the transfer finalised until they have received a copy of the Department of Natural Resources, Mines and Energy Registration Confirmation Statement completed with the buyer's details. Once this statement has been received Fraser Coast Regional Council will update their records and billing information

WARNING

Any transfer of money between the buyer and seller is made at their own risk and does not involve Fraser Coast Regional Council.

The buyer should not begin accessing the water relevant to this transfer/sale until they have received confirmation from Fraser Coast Regional Council that the transfer/sale has been approved. If a buyer exceeds its existing entitlement and the transfer/sale is refused, Fraser Coast Regional Council are required to report the buyer to the Department of Natural Resources, Mines and Energy.

Approval of Pumps

The buyer must ensure they have obtained approval under the planning legislation for their pump. This may include prior approval under a license.

Land Management

You may wish to contact the Department of Natural Resources, Mines and Energy to clarify any requirements for a Land and Water Management Plan.

Volume that can be transferred/sold

The maximum amount the seller may transfer/sell is the volume available to the seller at the time of application. By signing this form, the seller warrants they have sufficient water available for the transfer/sale.

Water Charges

Fixed (Part \bar{A}) and Consumption (Part B) charges are payable for all water taken where the Water Supply Contract applies. Fees and charges for each financial year can be found on Council's website.
