## New Animal Registration Form / Change of Ownership Form

Local Law No. 2 (Animal Management) 2011 and Animal Management (Cats and Dogs) Act 2008

## **IMPORTANT INFORMATION**

- It is mandatory for dogs 12 weeks and over to be registered.
- Registration of an animal does not automatically permit the animal to be kept on a property in contravention of Councils Local Laws.
- No more than the allowable number of animals per land size are allowed to be kept on any property, unless a permit to do so has been approved.
- No more than one (1) dog is allowed to be kept in a residential unit (residential development comprising multiple units on a single lot; multiple dwellings; duplex, accommodation units, caravan park or retirement village); unless a permit to do so has been approved.
- Animal registration renewal fees apply refer to the Fees & Charges schedule.
